#### Administration and costs

VPS subscription for two servers provided by OVH was paid US\$4.00 on Monday, Dec 1<sup>st</sup>. The invoice with credential reference WE4083094 will be uploaded to the designated public repository created under the <u>ASA Stats GitHub organization</u>, just before custody of the ASA Stats project is transferred to the ASA Stats DAO.

VPS subscription for one server provided by OVH was paid US\$26.00 on Friday, Dec 5<sup>th</sup>. The invoice with credential reference WE4097734 will be uploaded to the designated public repository created under the <u>ASA Stats GitHub organization</u>, just before custody of the ASA Stats project is transferred to the ASA Stats DAO.

Monthly usage for EX44 Dedicated Server provided by Hetzner was paid 55.00 € on Thursday, Dec 25<sup>th</sup>. The invoice with credential reference 089000661200 will be uploaded to the designated public repository created under the <u>ASA Stats GitHub organization</u>, just before custody of the ASA Stats project is transferred to the ASA Stats DAO.

On <u>Sun, 28 Dec 2025 15:47:01 UTC</u>, the Keeper sent 1,500,000 ASASTATS from the Manager account to Pact escrow. Those funds will be allocated in January as additional rewards for contributors to the ALGO/ASASTATS liquidity pool on Pact, which is qualified as a consensus-based pool.

On Mon, 29 Dec 2025 12:10:45 UTC, the Keeper sent 140.00 ALGO from the *dualSTAKE escrow* to the Team's Nexo account. It is expected that those funds would be spent by the admpool and the Team in the following period.
